- No trash. Take all trash with you. Please leave event area better than you found it
- Stay in blinds, holding blinds, any galleries, or any other designated areas as instructed
- Gun handling safety, which includes shotguns, firearms, handlers shotguns, blank pistols, and any replica of such firearm, is required at all times
- Good sportsmanship conduct is required at all times
- Adhere to all rules and regulations as set forth by the AKC for field trials, hunt tests, and any and all training sessions as arranged by Pinelands Retriever Club of New Jersey

2. Assent and Release

Permission is hereby granted to the undersigned participant to attend, participate, and work as requested on the grounds as selected by Pinelands Retriever Club of New Jersey. The participant agrees to be responsible for his/her own safety while present in any and all Pinelands Retriever Club of New Jersey events and the lands selected. This permit covers only the lands selected by Pinelands Retriever Club of New Jersey and the participant agrees to respect the land of adjoining landowners.
